BRUNTON PARK FLOOD ALLEVIATION

PROGRESS UPDATE

Tuesday 10 May 2016 marked a key milestone in the project with the successful turning of flows into the new Ouseburn channel. With the new channel now in operation, we are progressing with the completion of the flood embankment including filling the old channel at both ends of the diversion. We saw an increase in construction traffic over a three day period when we brought additional clay to site, however, we now have sufficient material on site to complete the construction of the flood embankment.

Excavation of the SuDs storage basin will begin on Monday 4 July 2016 and will take up to four weeks to complete. During this period, there will be a further noticeable increase in construction traffic while we remove the excavated material.

Newcastle City Council has appointed a contractor to carry out the construction of the new play park on Lincoln Green. Work will begin on Monday 6 June 2016 and will take up to five weeks to complete. The temporary compound hoarding will be removed in time to open the play park ready for the start of the school summer break. The final reinstatement of Lincoln Green will follow completion of our

With the majority of the estate's surface water (from roofs, roads and drives) now discharging to the old Ouseburn channel, we have found trace evidence of wastewater, such as washing machines, dishwashers, toilets, baths, showers and sinks in our surface water system due to misconnections. This occurs when pipes carrying wastewater are connected to surface water sewers accidently. This is having a damaging impact on the water quality within the SuDs storage channel and it is vital that we carry out detailed drainage surveys of individual properties as quickly as possible.

Our experienced survey team will be working within the estate over the coming weeks to inspect our sewerage system and carrying out free drainage surveys on properties in targeted areas.
